SOLID WASTE MUC DECAL PROGRAM

Albemarle County residents may now apply for a Solid Waste MUC decal that will allow for faster entry when using the Ivy Material Utilization Center. Information on how to obtain a decal is on the reverse side.

We encourage regular County users of the Ivy Material Utilization Center to obtain and display this decal to facilitate entry. However, a Solid Waste MUC decal is not required and residency can still be established by showing your vehicle registration, voter registration card, Albemarle County Service Authority water bill and personal property or real estate tax bill during each visit to the facility.

The decal is not transferable and may be revoked if used in violation of the decals intent including the requirement that the decal not be given to or shared with non-County residents. The decal does not relieve you of any fees that may be applicable. RSWA staff reserves the right to ask for other identification.

There is no charge for this decal and the decal does not expire.

The decal must be permanently affixed to the inside of the vehicle windshield in the blind spot behind the rear view mirror. Loose or taped decals will not be accepted. Vehicles that do not have a rear view mirror will be issued a decal to be placed on the outside of the vehicle, as designated by the Scale Attendant at the Ivy Material Utilization Center, based on vehicle type.

- ❖ Fax the completed form along with a copy of your vehicle registration, Albemarle County Service Authority water bill, personal or real estate tax bill to the Ivy Material Utilization Center at (434) 295-0822 or the Administration Office at (434) 293-8858.
